J. Starck updated the Board on various HDR projects not covered under either Unfinished or New Business. 2020 Wastewater Lagoon Improvements The project is currently in a winter "shut-down" until Cell 3 baffle can be installed; A "Notice to Stop Work" has been issued to stop the Contract Time until work can resume in the spring. All work is required to be completed no later than April 1, 2022 Aerators are still running manually until parts arrive. The survey and updates for the As-Constructed Drawings are mostly completed. Wastewater Headworks The conceptual site layout and building layout is complete and work will resume on the design. RJ-2 Pumphouse Property corners were marked and will continue to assist as requested for design and permitting for pumphouse replacement. Misc. Services Will coordinate as needed to get the plats filed with the county for the Legal Exhibit for Lagoon Land Purchase.
