J. Stark updated the Board on the 2020 Wastewater Lagoon Improvements Schedule. Met with Earth Work Solutions to discuss landowner coordination for sludge removal. Plan to start sludge removal in late July or August. Getting estimates for reseeding the area. Design and permitting will be required to abandon the existing lagoon cells no longer in use. Have been progressing with design for plant lift station wastewater screening. Start preparing grant application. Assistance for design and permitting the replacement for RJ-2 pumphouse. Planning to submit a design proposal next month for RJ-9 well drilling. Office of State Lands and Investments have opened application for grants.

OPERATORS' REPORT

L. Strohschein gave the operators' report for the past month citing the following specifics: Water/Sewer samples were good for the month; Finished brush hogging South of town; Courtesy shut off to replace shutoff valve on Highridge; Fire hydrant maintenance (greasing) ongoing; Isolated area on Commercial Drive to check on running water and no leaks were found; Utility bed installed on the 2022 Ford; Finished with our yearly valve exercising in town; Manholes above fishing pond were checked for buildup and were good; Met with HDR and Earthworks about sludge removal; Removed 3 abandoned curb stops on Story to salvage parts; Had one turn off; Had one turn on; Had 18 door knockers; Had six final reads; Changed Chlorine bottles at both tanks and Hawkins delivered Chlorine and Sodium Bisulfate; Rebuilt fire hydrant on Sundance Circle; Jetted manholes along 387; Used camera to view possible obstruction in sewer mains leading up to the hotel; Stripped pump cases at the plant lift station and cleaned off old paint and debris; Received quotes on a new pump install in RJ-2; Finalized title paperwork for 2022 Ford; Installed new Chlorine injector on the new tank; Replaced air pump in plant lift station; Cleaned the pilot valve on the hammer valve on RJ-8; Helped with backflow install at Clubhouse; Demoed the blower building on Pond 1; Demoed inside of RJ-2; Working with DRM on locates for fiber install; Cleaned both pumps at the plant lift station due to rags; Picked up new skid mounted sprayer and all well yards are done; Spoke with homeowner on Willowcreek about plumbing possibilities for sprinkler system; Spoke with homeowner on Range Circle concerning water PSI issues; Fire hydrant was installed on Summer Court to assist with flushing, sidewalk and street repair was completed; Cleaned wet well and disposed it in Gillette; Helped town with line hookup on town irrigation meters; Sent samples to lab; Spoke with homeowner on a possible water leak on Sandcreek Circle; Answered questions concerning installation of taps along Hwy 387
